



TRANSFER ARTICULATION AGREEMENT

between

LANE COMMUNITY COLLEGE, UNITED STATES OF AMERICA

and

RENNES SCHOOL OF BUSINESS, FRANCE

for

ASSOCIATE OF SCIENCE OREGON TRANSFER IN DEGREE IN BUSINESS

and the

INTERNATIONAL BACHELOR PROGRAM IN MANAGEMENT

The intent of this articulation agreement is to define the procedures for a transfer articulation between Rennes School of Business (hereinafter RSB) and Lane Community College (hereinafter LCC). Both entities agree to mutual cooperation in establishing and maintaining articulation for their respective programs :

- 1) LCC Associate of Science Oregon Transfer Degree in Business with its campus located at 4000 East 30th Ave., Eugene, Oregon, United States of America
- 2) RSB International Bachelor Program in Management with its campus located at 2 rue Robert d'Arbrissel, 35065, Rennes, France

The agreement is intended for students having completed an Associate of Science Oregon Transfer Degree in Business, who wish to transfer to RSB and obtain RSB International Bachelor Programme in Management Degree.

Firm arrangements between departments and institutions provide the opportunity for these students to obtain a complete Bachelor degree through program to program agreement, at the outset of their Community College education.

Rennes School of Business agrees to accept all Business and Major education credits. General Education credits will also be accepted (see Appendix A).

- 1) Students who have completed an Associate of Science Oregon Transfer Degree in Business at LCC may transfer to Rennes School of Business's International Bachelor Program in Management with senior standing provided that the student has completed all Business courses identified in Appendix A, with a cumulative GPA of 2.00 or higher.
- 2) If RSB considers that a candidate lacks certain fundamentals in Business, a « Business & Management Preparation Course » will be offered online before the start of the semester. This programme will help students acquire the understanding of concepts in the following five key areas of Business & Management : Marketing – Strategy & Innovation – Finance & Accounting – Supply Chain Management - Organizational Behaviour & Human Resource

Management.

The invoice will be adapted to the number of modules required.

- 3) Students who earn an Associate of Science Oregon Transfer Degree in Business at LCC are guaranteed admission to the last and final year of the International Bachelor Programme in Management conditional upon meeting the prerequisites of the minimum requirements for admission.
- 4) After completing the International Bachelor Program in Management, students may be admitted to one of the Master Programmes in Management/Business offered at Rennes School of Business in only one year, should they wish to pursue their studies (2+2).
- 5) LCC will inform prospective students of these 2 + 1 & 2+2 partnerships and will promote these on their website. LCC will provide Rennes School of Business with the contact information of students interested by this opportunity.
- 6) LCC and Rennes School of Business will assign a staff member to serve as a liaison to assure maintenance of communication between the two institutions. Representatives from both institutions will consult, whenever changes in policy or curricula arise, which may affect students transferring under the terms of this agreement.

This agreement will be in effect initially for three years, beginning fall 2017 with a review every year by both parties. Any revisions the parties deem necessary must be evidenced in writing and signed by the authorized officials of each institution. The agreement may be terminated by either party for due cause and after adequate notice of not less than six months if deemed necessary by either party.



Note for students who do not speak English as their first language:

In order to apply, students do not have to present an english test. However, an official english test is a requirement in order to be granted the Bachelor Degree (unless they are native english speakers). Students will need to pass the test while studying in Rennes if they ahve not done it before attending. Rennes offers two sessions of TOEIC in the school during the year for a cost of 50€. Students will need to register to one of them on arrival.
