PRIVACY

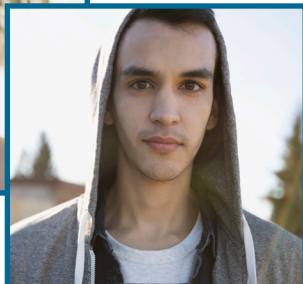
- Do you want your employer, landlord, school, or college to keep your information private?
- Do you have concerns about what information about you the perpetrator can access?

SAFETY

- Do you feel unsafe at home, work, and/or school?
- Are you being harassed or contacted by the perpetrator?
- Do you want to change your name and/or gender marker documents to protect your safety?

EDUCATION

- Are you having trouble in middle school, high school, or college following the assault?
- Is the person who assaulted you part of your school community (i.e., a student or employee)?



IMMIGRATION

- Are you worried about your immigration status?
- Are you concerned about your legal rights as an immigrant, refugee, or undocumented person?



HOUSING

- Do you feel unsafe where you live?
- Do you feel discriminated against by your landlord?



EMPLOYMENT

- Are you having trouble at work?
- Did you lose your job, or get harassed or disciplined at work?
- Do you need a leave of absence or other accommodations to stay employed?



FINANCIAL STABILITY

- Do you have unpaid bills?
- Do you need public benefits, victim assistance, or other financial support?
